PRVD2022-18: strychnine and sodium monofluoroacetate

Please accept this submission of AEL Advocacy in response to Health Canada's Proposed Re-evaluation Decision 2022-18.

A. About AEL Advocacy

Animal Environmental Legal Advocacy ("AEL Advocacy") is a public interest law practice and not-for-profit organization. Our lawyers understand the important interconnection between humans, animals, and the environment. We combine our in-depth knowledge of the legal and political landscape with a commitment to supporting individuals and organizations working to protect animals and the environments where they live.

B. Comments on the Proposed Continuation of Strychnine for Predacide Use

AEL Advocacy is strongly opposed to the continued registration of the predacide uses of strychnine and sodium monofluoroacetate and all associated end-use products registered for the use of sale in Canada because of the inhumane suffering these compounds cause to its victims.

There are copious studies demonstrating that strychnine causes gruesome and prolonged suffering to its victims (both target and non-target animals).¹ That is, strychnine causes agonizing symptoms including convulsions, vomiting, hallucinations and respiratory arrest which eventually kills the animal (after extensive time ranging from hours to days).² Moreover, non-target animals are often subjected

to this tragic fate including both people's beloved companion animals, as well as endangered species.³

We urge Health Canada to withdraw this proposal and instead ban these extreme predacide products forthwith.
